Who is running the giveaway?	Clifford Gardens Shopping Centre, Corner James Street and Anzac Avenue, Toowoomba, Qld, 4350 (ABN 23 318 856 072).
When will the giveaway start and end?	The competition runs from 9am 19/09/2020 until 2:00pm 05/10/2020 (the Competition Period).
Who can enter?	Only Australian residents aged 18 or over can enter. Photo identification may be required.
Who can't enter?	Directors, officers, management and employees of: (a) the Promoter; (b) the agencies or companies associated with this competition or the Promoter; or (c) the retail stores located at the Centre, and the immediate families of those people, can't enter.
Where will the giveaway run?	The competition will run in all retail outlets in the Centre, Cnr James Street & Anzac Ave, Toowoomba, Queensland.
Do I need to buy anything to claim a gift?	Yes. During the Promotional Period, customers must spend \$60 in a single transaction at any Clifford Gardens speciality retail store OR \$80 in a single transaction at Big W, Coles or Woolworths (Qualifying Purchase) to receive a 'Bake at Home Jar.'
