Who is running the competition?	Clifford Gardens Shopping Centre, Corner James Street and Anzac Avenue, Toowoomba, Qld, 4350 (ABN 23 318 856 072).
When will the competition start and end?	The competition runs from 9am 16/01/2021 until 2:00pm 26/01/2021 (the Competition Period).
Who can enter?	Only Australian residents aged 18 or over can enter. Photo identification may be required.
Who can't enter?	Directors, officers, management and employees of: (a) the Promoter; (b) the agencies or companies associated with this competition or the Promoter; or (c) the retail stores located at the Centre, and the immediate families of those people, can't enter.
Where will the competition run?	The competition will run in all retail outlets in the Centre, Cnr James Street & Anzac Ave, Toowoomba, Queensland.
Do I need to buy anything to claim an entry form?	Yes. During the Promotional Period, customers must spend \$50 in a single transaction at any Clifford Gardens retail store (Qualifying Purchase). For clarity, the Qualifying Spend receipts cannot be combined, however one entry form will be issued for every receipt presented that meets the competition criteria.
